
To establish an action plan to implement and mandate consistent procedures for the planning, design, construction, maintenance and enablement of cycle transport in Derby City.

**Applies equally to walking – Active Travel**



### **Cost Effective Cycle Infrastructure**





### **Set Principles:**

- Give vulnerable traffic priority
- Continuous rights of way at side roads
- Surface quality equivalent to main carriageway
- Cyclists don't stop more often than cars
- Inclusive transport design (panniers, trailers, trikes, the "standard design vehicle")
- Campaigning for better rules/laws (eg British Cycling "Turning the Corner")



#### Standards:

- Adopt current national and local standards
- Cycle audit mandated in council procedures
  - Adopt a cycle audit procedure, off the shelf.
  - Development Control Planning Application review
    - . Set planning conditions with reference to LCWIP
    - . Set construction standards
    - . Commissioning audits + rigorous rectification
  - Infrastructure projects (London Road Rail Bridge; Infinity Park Way)
  - Developer projects (Castleward; Manor Kingsway; Varsity Grange)
  - Highways maintenance
    - . Resurfacing/top dressing
    - . White lining
    - . Standards for pothole intervention on the cycling line



#### Enabling Behaviour Change: Strategic Soft Measures

- Cycle training plan
  - Schools
  - Workplace
  - Community
  - Household
- Promote new routes / events / rides
- Smart choices travel planning
- Healthy living
- Benevolence/Empathy
  - West Mid's Police: "Close Pass"
  - Arriva Midlands: "Share the Road"



### **Cycle Transport Strategy**

- Create high level document <u>quickly</u>
  - Short: vision and aspiration
  - Involve full council (political buy-in)
  - Approve at full council meeting
- Develop LCWIP
  - Long term strategy
  - Indentify & implement quick wins
- Develop detailed documents
  - Strategic Cycle Network Development Plan
  - Map of the network
  - Design/build standards
  - Audit & Review procedures
  - Strategic soft measures targeting behaviour change



#### Speed is of the essence – lets get to it!



- Quick Wins (2017):
  - Set some high level principles
  - Assign design standards to use
  - Implement a cycle auditing policy
  - Write & approve high level cycle strategy
- Short Term (early 2018)
  - Develop LCWIP
  - Identify and develop quick win projects
- Medium Term (end 2018)
  - Develop LCWIP detailed documents

#### Cyclic – measure / review / improve: raise the standard

- All council departments sign up to cycle auditing
- Pragmatic quick response from:
  - Planning
  - Highways
