3 Campaigns

3.1 Ride with Council Active Travel Team

JB to agree date with Mark Smith of Derby City Council. Likely to be during working hours. **JB** to circulate planned route and notes.

3.2 Station Road Crossing

Still no crossing in place on Station Road in Mickleover although "promised" for FY24-25 (i.e. before April 2025). TR has been in contact with local Councillors as has James Bailey and Tony Gordon. 3.3 Local work in progress

Cycle related work is in progress on Ashbourne Road, Spondon area (around Asda) and Nottingham Road in Chaddesden. To be reviewed on completion. Feedback on plans was provided previously – as work is now in progress the plans can no longer be influenced.

3.4 Duffield Road bus lane

ID met with Derby City Council and has provided feedback via Derby's Lets Talk on behalf of the DCG. DCG is not supportive of the plans as they currently stand as the experience for cyclists will be worse than that currently in place. **ID** to submit, again, detailed information to the Council. 3.5 Active Travel Map

3.6 NCN barriers

Just one A frame barrier remains on NCN in Derby area (other restrictions remain – e.g. steep slopes, narrow sections). ID has documented the extensive improvements to the National Cycle Network in the Derby area (see DCG website) and has asked Derby City Council to remove the one final A frame barrier on the NCN. 5.1 LCWIP

It is understood that Derby City Council are preparing a city focused LCWIP. No timescales or further information. Creation of a new version of the LCWIP would be a useful action for the local active travel forum.

5.2 Derbyshire Cycling Plan

This was launched in 2016 with the goal of making Derbyshire "the most connected county for cycling by 2030". Discussion with the group responsible for the plan (Active Derbyshire) is that the various stakeholders do not see the plan as a priority and, instead, focus will be on schemes such as Walk Derbyshire.
